5. The District reserves the right to reject any or all bids and waive any formalities in bids received. Price alone may not be the determining factor. Award will be based upon those considerations, are in the best interest of the District and will be made to the responsive, responsible bidder whose bid is judged to be the most effective and economical for the requirements and specifications stated in the Invitation to Bid. Proposals which fail to comply fully with any provision of the bid documents will be considered invalid and will not receive consideration.
